Bidders needs to sign a Bid securing declaration accepting that if they withdraw or modify their Bids during the period of validity, or if they are awarded the contract and they fail to sign the contract, or to submit a performance security before the deadline defined in the request for bids/request for proposals document they will be suspended for the period of 1 year for or bids/request for proposals document from being eligible to submit Bids/Proposals for or contracts with ICMR. 3. Eligibility: The Bidder must be a Manufacturer or its authorized Agent. 4. One Bid per Bidder: A firm shall submit only one bid either individually or as a partner of a joint venture. A firm that submits either individually or, as a member of a joint venture, more than one bid will cause all the proposals with the firms' p

articulation to be disqualified. 5. ICMR-NIV reserves the right to cancel the bid in part or full without assigning any reason and liability on the buyer. Since the Liquidated damages are in virtue of non-performance of services, it will attract GST or any other applicable taxes which in turn shall be deducted from the Supplier. 13. GST will be applicable as per the latest Govt notification. 14. Delivery of Equipment means Supply, Installation, and Testing of Equipment. 15. Following Categories Sellers are exempted from Years of Experience and Turnover. (a) Micro and Small Enterprises who are manufacturer of the Primary Product Category and give specific confirmation to this effect at the time of bid submission and whose credentials are validated online through Udyam Registration/ Udyog Aadhaar (as validated by Government from time to time) and through uploaded supporting documents.
