Detailed Specifications for Sample Mixer Compatible with NGS Library Preparation

PP No: 498/2024-25

1. The equipment should have an adjustable speed range from 1-100 rpm, with orbital rotation, reciprocal rotation and vibration to achieve proper mixing of samples, with rotating angles from $1-90^\circ$

2. Minimum of two different platforms must be provided to match tubes of varying

volumes ranging from 0.5-50 mL.

3. The equipment should have a wide range of working temperatures [4-40°C necessary]

4. The equipment should be supplied with necessary cables and connectors, compatible with Indian standards, including any necessary adapters. V/A: 120/0.5

5. The equipment should be equipped with an onboard timer, with minimum range of 1-250 seconds

6. The equipment should be compatible with magnetic bead based nucleic acid purification kits.
