1. If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking exemption from Experience Criteria, shall upload the supporting documents to prove his eligibility for exemption.

2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. 3. 6. 8. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. 10. 4. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

12. Generic

1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.

vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

14. Turnover

2. Bidders needs to sign a Bid securing declaration accepting that if they withdraw or modify their Bids during the period of validity, or if they are awarded the contract and they fail to sign the contr act, or to submit a performance security before the deadline defined in the request for bids/reques t for proposals document they will be suspended for the period of 1 year for bids/request for propo sals document from being eligible to submit Bids/Proposals for contracts with ICMR.

3. Eligibility: The Bidder must be a Manufacturer or its authorized Agent.

4. One Bid per Bidder: A firm shall submit only one bid either individually or as a partner of a joint venture. A firm that submits either individually or, as a member of a joint venture, more than one bid will cause all the proposals with the firms' participation to be disqualified.

5. ICMR reserves the right to cancel the bid in part or full without assigning any reason and liability on the buyer. On such cancellation the decision of the DG, ICMR will be binding and final on the su bject.

6. Inspections and Tests: ICMR or its representative shall have the right to inspect and/or to test th e Goods to confirm their conformity to the Contract specifications . Further, The Supplier may have an independent quality test conducted and the cost of such tests will be borne by the Supplier.

7. Packing : (a) The Supplier shall provide such packing of the Goods as is required to prevent their damage o_deterioration during transit to their final destination, as indicated in the Contract. The packing shall be sufficient to withstand, without limitation, rough handling during transit and expo sure to extreme temperatures, salt, and precipitation during transit and open storage. 11. Unless otherwise instructed, the supplier shall make arrangements for insuring the goods agai nst loss or damage incidental to manufacture or acquisition, transportation, storage and delivery i n the following manner:

a) In case of supply of goods on Consignee site basis, the supplier shall be responsible till the entir e store contracted for arrival in good condition at destination. The transit risk in this respect shall be cove red by the Supplier by getting the stores duly insured. The insurance cover shall be obtain ed by the Supplier and should be valid till 3 months after the receipt of goods by the Consignee.

(b) If the Equipment is not commissioned and handed over to the consignee within 3 months, the i nsurance will be got extended by the supplier at their cost till the successful installation, testing, c ommissioning and handing over of the goods to the consignee. In case the delay in the installation and commissioning is due to handing over of the site to the supplier by the consignee, such exten sions of the insurance will still be done by the supplier, but the insurance extension charges at act ual will be reimbursed.

(c) Insurance would be borne by the Supplier. Insurance Certificate for 110% of the value to be ins ured in favour of Indian Council of Medical Research, covering all risks basis for the goods from su pplier/ manufacturer warehouse to consignee ware house

12. If the supplier fails to deliver any or all of the goods or fails to perform the services within the t ime frame(s) incorporated in the contract, the purchaser/consignee shall, without prejudice to othe r rights and remedies available to the purchaser/consignee under the contract, deduct from the contract price, as liquidity damages, calculated individually on each delayed performance of the contract including delivery, installation, non-submission of documents, etc. a sum equivalent to 0. 5% per week of delay or part thereof until actual delivery or performance subject to a maximum o f 10% of the contract price. Once the maximum is reached purchaser may consider termination of the contract. Since the Liquidated damages are in virtue of non-performance of services, it will attract GST or any other applicable taxes which in turn shall be deducted from the Supplier

13. GST will be applicable as per the latest Gal notification.

14. Delivery of Equipment means Supply, Installation, Testing and Commissioning of Equipment.

15. Following Categories Sellers are exempted from Years of Experience and Turnover.

(a) Micro and Small Enterprises who are manufacturer of the Primary Product Category and give s pecific c confirmation to this effect at the time of bid submission and whose credentials are validat ed online through Udyam Registration/ Udyog Aadhaar (as validated by Government from time to time) and through uploaded supporting documents.

(b) Start-ups as recognized by Department of Industrial Policy and Promotion (DIPP).

16. The manufacturer's authorization must be insisted upon on a tender specific basis, not general authorization/'dealership, by so declaring in the bid documents clearly. In cases where the manufa cturer has submitted the bid, the bids of its authorized dealer will not be considered. In cases of a gents quoting in offshore procurements, on behalf of their principal manufacturers, one agent can not represent two manufacturer s or quote on their behalf in a particular tender enquiry. One man ufacturer can also authorize only one agent/dealer.

17. Bidder is requested to give undertaking Certificate regarding land border "I/ We have read the clause is sued by Government of India regarding restrictions on procurement from a bidder of a co untry which shares a land border with India; I/We certify that the bidder is not from such a country or, if from such a country, have been registered with Competent Authority
