Under Prime Minister-Ayushman Bharat Health Infrastructure Mission (PM-ABHIM) Scheme, DHR-ICMR is implementing six major infrastructural projects: Four regional NIVs (at Bangalore, Jabalpur, Dibrugarh and Jammu), National Institute for One Health at Nagpur and a division for Research on Disease Elimination Sciences & Health as a Satellite Centre of ICMR-NARI Pune.
